EXPRESSION OF INTEREST (EoI)

Inviting applications for establishment of New Animal Feed Plants/ Modernizing of existing Animal Feed Plants in the State of Andhra Pradesh under AHIDF Scheme.

Directorate of Animal Husbandry (DAH), Government of Andhra Pradesh, is inviting applications from Eligible Entities **to establish Animal Feed Plants and strengthening of existing units/plants in the state of Andhra Pradesh under the AHIDF Scheme.**

Under the Prime Minister's Atma Nirbhar Bharat Abhiyan stimulus package, Animal Husbandry Infrastructure Development (AHIDF) Fund has been approved with the total fund of Rs.15000 Crore for incentivizing investments by **Eligible Entities** to establish

- (i) Dairy processing and value addition infrastructure,
- (ii) Meat processing and value addition infrastructure and
- (iii) Animal Feed Plant.

The Objectives of fund is to help increasing of milk and meat processing capacity and product diversification thereby providing greater access for unorganized rural milk and meat producers to organized milk and meat market, to make available increased price realization for the producer, to make available quality milk and meat products for the domestic consumer, to fulfill the objective of protein enriched quality food requirement of the growing population of the country and prevent malnutrition in one of the highest malnourished children population in the world, develop entrepreneurship and generate employment, to promote exports and increase the export contribution in the milk and meat sector and to make available quality concentrated animals feed to the cattle, buffalo, sheep, goat, pig and poultry to provide balanced ration at affordable prices.

Applications are invited by the DAH from the Eligible Entities who shall be i) Farmer Producer Organizations (FPOs), ii) MSMEs, iii) Section 8 companies, iv) Private companies and v) Individual entrepreneurs to establish Animal Feed Plants in the state.

The following are the financial incentives applicable for eligible entities under AHIDF are below:

- Interest subvention of 3% can avail to all eligible entities, if EE is not a defaulter of re-payment of loan amount in any given year. Interest subvention is will not be allowed for land cost, working capital, old machinery and vehicle for personnel use.
- The Credit Guarantee will be provided to only projects which are viable and are cover under MSME defined ceiling and the guarantee coverage would be up to 25% of the credit facility available to the borrower. The Credit Guarantee fund will be managed by NABARD. The Credit Guarantee will not be provided to other beneficiaries who are not covered under MSME norms; however, those EEs will be eligible to get interest subvention.
- Loan up to 90% of the estimated/actual project cost of the viable project will be provided by banks from the scheduled bank and beneficiary contribution is 10% in case of Micro and Small, up to 15% in case of Medium and up to 25% in case of large units.
- The repayment period loan would be 8 years inclusive of moratorium if 2 years on principal amount. The maximum re-payment period should not

exceed 10 years from the date of first disbursement inclusive of moratorium of 2 years on re-payment of principal.

In addition to the above, the Eligible Entities being supported under the AHIDF would also be eligible for benefits from Government Schemes as per the scheme guidelines.

1. PM Formalization of Micro food processing Enterprises Scheme (PM FME Scheme) for providing financial, technical and business support for up gradation of existing micro food processing enterprises.

- Individual micro food processing units desirous of up gradation of their unit can avail credit-linked capital subsidy @ 35% of the eligible project cost with a maximum ceiling of Rs.10 lakh per unit. The beneficiary contribution should be minimum 10% and the balance should be loan from a Bank.
- The Scheme would support clusters and groups such as FPOs/SHGs/Producer Cooperatives along their entire value chain for sorting, grading, assaying, storage, common processing, packaging, marketing, processing of Agri-produce, and testing laboratories. The credit linked grant is @ 35% and maximum limit of grant in such cases would be as prescribed.
- Credit linked grant @35% would be provided to FPOs, Cooperatives, State owned agencies and private entrepreneurs for development of common infrastructure including common processing facility, lab, warehouse, cold storage, packaging and incubation center

2. Micro & Small Enterprises - Cluster Development Programme (MSE-CDP)

- Common Facility Centers (CFCs): The Gol grant shall be for a maximum of 70% of the Project Cost of maximum Rs.20.00 crore. Gol grant shall be 90% for Clusters with more than 50% (a) micro/ village, (b) women owned, (c) SC/ST units.
- Infrastructure Development: The Gol grant shall be for a maximum of 60% of the Project Cost (Rs.10.00 crore for Industrial Estate & Rs.15.00 crore for Flatted Factory Complex). Gol grant shall be 80% for industrial areas / estates / Flatted Factory Complex with more than 50% (a) micro/ village, (b) women owned, (c) SC/ST units. For existing clusters, up gradation proposals shall be based on actual requirements.

- iii) **Convergence:** Evaluation of convergence possibility of AHIDF loan with supports from other subsidies or grants for enhancing viability.
- iv) **Assisting in preparation of DPR:** Hand holding in preparation of DPR for Applicants / Eligible Entities.
- v) **Submission of application on portal:** Evaluation of proposal viability and support the beneficiaries in submission of AHIDF application on the portal.

- vi) **Sanction of Loan and Project initiation:** Assisting the Applicants / Eligible Entities in the process till the proposals are submitted to SCBs or DCCBs and ensure timely disbursal.
- vii) **Monitoring and evaluation of progress:** Monitoring the progress of each beneficiary and evaluation of progress at project level, District level for efficient implementation.

A Success fee of 2% of the project cost to be paid by the Eligible Entities (EE) to APUIAML for availing the above services after the successful initiation / implementation of the project(s) pursuant to the sanction and disbursement of amount under this scheme.
