ORDER:-

Government, in order to give support to the efforts of the Nellore Municipal Corporation to drive economic growth and improve the quality of life of people decided to provide Rs.33.00 crore / annum for a period of 3 years. The Nellore Municipal Corporation shall through a Mission mode approach shall develop and execute the Projects identified for the purpose. A Special Purpose Vehicle (SPV) constituted for the purpose will plan, appraise, approve, release funds etc., and evaluate Projects in the ULB on the lines of the Smart City Development. The Special Purpose Vehicle will be a limited company incorporated under the Companies Act, 2013 at City Level, in which the State and the Urban Local Body will be the promoters having 50:50 equity share holding.

2. Government accordingly hereby constitute a Special Purpose Vehicle in the name and the style of "**Nellore Smart City Corporation Limited**" under the State Initiative of Smart City Scheme structured on lines of Government of India Smart City Mission. The SPV shall have a team of Board of Directors (BoD), headed by a Non-Executive Chairman and 15 other directors. The following officers are nominated as initial directors on the Board of the Nellore Smart City Corporation Limited.

3. The Special Purpose Vehicle is owned by the State Government and the Nellore Municipal Corporation in 50:50 ratio and will be governed by a Board of Directors and is answerable to Government of Andhra Pradesh, and Nellore Municipal Corporation. The Special Purpose Vehicle is responsible for effective and timely implementation of the Programme of Nellore Municipal Corporation as per the rules and guidelines issued by the state Government from time to time.

4. The authorised share capital of SPV for incorporation will be Rs.5.00 lakhs initially and this will be increased later on as and when required. The paid up capital of the Special Purpose of Vehicle will be Rs.5.00 lakhs divided into 50,000 equity shares of Rs.10/- each. The Authorised and paid up Share Capital will be increased as and when the funds are released to the SPV. The following officers are nominated as initial shareholders of the SPV.

Government authorises the Principal Secretary to Government, MA & UD Department and the Commissioner, Nellore Municipal Corporation to sign the incorporation papers of the SPV on behalf of the Governor of Andhra Pradesh and the Nellore Municipal Corporation respectively. The Government also permits the Commissioner, Municipal Corporation, Nellore to incur the incorporation and initial expenditure for establishing the SPV and to treat the expenditure as the subscription amount of Nellore Municipal Corporation in the Special Purpose Vehicle of Nellore.

6. The Commissioner, Nellore Municipal Corporation shall submit Memorandum of Association and the Articles of Association of the SPV prepared as per the guidelines issued by the Ministry of Urban Development and in accordance with the Companies Act, 2013 for incorporation of an SPV.

7. Government hereby appoint the Andhra Pradesh Urban Infrastructure Asset Management Company Limited (APUIAML) as PMC and technical consultant for the Development of Nellore as a Smart City through the Special Purpose Vehicle.

8. The Commissioner, Nellore Municipal Corporation shall take further necessary action in the matter.
