This unit is intended to create a continuous demand to the farmers produce, good sale price & good quality meat to the end consumers. The main objective of this EoI is to invite the experienced players of National repute with an established market, processing a diverse distribution and customer chain through O&M of such Slaughter House(s) / Abattoir(s) / Meat Processing Units.

#### 1. BACKGROUND

Andhra Pradesh government had rolled out new and innovative AP Food processing policy 2020-2025, wishes to address the problems of Farmers, producers and Processing industries with a unique model to sustain, develop and add value to the produce in the state.

India is the largest producer of buffalo meat (16.62 Lakh MTs), second largest producer of goat meat (5.06 Lakh MTs) and third largest producer of broiler meat (35.91 Lakh MTs) globally during 2018-19. The total meat production in India was 81.14 Lakh MTs during 2018-19.

Andhra Pradesh occupies 4th position in meat production in the country with an estimated production of 7.81 Lakh MTs as per the approved estimates of Govt of India during 2018-19. The meat sector contributes Rs.30,821 Cr to the GSDP of the State. The meat sector in Andhra Pradesh provides livelihood for about 4 lakh farmer families.

For promoting meat processing sector in AP in a big way, the State Government is implementing various innovative initiatives with focus on strong policy support as follows:

- Enhancing the meat production in the State by providing forward and backward linkages by distributing 2.49 lakh Sheep and Goat Units under YSR Cheyuta program through Animal Husbandry Department.
- Strengthening existing meat marketing for providing better price to meat and meat products by partnering with Allana Foods and other key private players in meat exports.

Other factors contributing for positive trends in Meat processing sector in Andhra Pradesh include - (a) changing consumer preferences (b) strong domestic demand and rising export opportunities (c) higher consumption levels (d) emphasis on health and wellness among consumers (d) new product innovation, specialized products and product extensions for the various existing food items.

Keeping in view of the very high potential for meat processing sector in Andhra Pradesh, it is proposed to establish Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units at various locations in Kurnool District.

## 2. AIMS & OBJECTIVES

Government of Andhra Pradesh (GoAP) is planning to establish Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units so as to bring uniformity in this sector which may be achieved through encouraging private sector participation in a less regulated way. Poultry, sheep & goat being the most consumed and produced meat products locally & internationally and if brought into a more processed and regulated way, the sector shall add value to the industry which may be achieved through practicing international practices and certain KPIs. Livestock mostly from rural areas find market in urban and semi-urban areas where there is concentration of consumers with higher purchasing power and meat processor can cater to a market comprising of individual consumers, supermarkets, and hotels.

Objective: To create structured Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units and subsidiary units in view of creating employment and market opportunities for

local farmers to sell their produce cutting down the middlemen. Increase the market potential of meat industry by focusing more on exports. Hence, develop standards in meat processing and introduce technology into the industry.

### 3. CONCEPT & METHODOLOGY

GoAP intends to encourage private sector participation, having similar expertise to establish Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units at Kurnool district. To bring the meat consumption into a more organized way where it used to be from processor to consumer. Now with the introduction of Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units, meat will be handled in a proper sanitary manner and storage and export opportunities will be increased. The intended / selected developer shall Establish the Unit(s) at the given Land parcels and perform the Processing / Canning of the meat, introducing different cuts, utilization of by products and disposing of the waste sanitarily. Meat export is considered as a profitable sector for the state considering logistical and supply chain advantages for the state.

## **Key Features:**

- ➤ GoAP / MDCAP shall provide Land on Lease basis to set up the subject unit. Land so provided should only be used solely for establishing Modernized Slaughter House(s) / Abattoir(s) / Meat Processing Units.
- Raw materials shall only be procured from local farmers in and around project location in A.P
- ➤ The subject unit & its subsidiary units shall carter the needs of the industry and create employment.
- ➤ Incentives shall be provided by GoAP / MDCAP as per the Industrial policy 2020-23 & Food Processing Policy 2020-25.

The subject unit shall be built in accordance with the current processing trends and modern infrastructure meeting global standards. Reputed and credible food/meat companies/industries/MNCs with established markets (National / International presence) having expertise in handling bulk volumes capable to absorb the volume shall be given preference.

This model can be termed as a Lease, Operate, Transfer of PPP model where in government shall provide land on Lease basis wherein reputed private industries will establish and operate the units, market & sell the produce with a win- win solution for farmers and the industry.

**Tenure of Allotment:** Land shall be given on lease for a period of 33 years, which may further be extendable up to 99 years with an option to buy the land after 10 years of successful operations at SRO price.

- The parameter for bidding shall be "Annual Lease Rent (ALR)" and the bidder quoting highest (ALR) shall be awarded the project and the selection shall be done through bidding process as per reverse tendering guidelines during RFP process.
- The Lease Rental shall be enhanced at the rate of 5% for every three years from the COD (Commercial Operations Date).
- Any interested investor can submit the proposal by paying Processing Fee / EMD etc., as per the prescribed model along with following supporting documents.

**Project Profile**—The Project profile would contain, the land location, land details, the estimated project cost, Minimum Development/O&M Obligations and other such details

The estimated project cost would include only the construction cost, Plant & Machinery Costs except Land & Operations cost to meet the Minimum Development Obligations

Appropriate implementation milestones along with implementation period shall be defined in the bid document.

The Project Profile shall also include of Capacity Proposed, Water supply & requirement, Effluent disposal & Solid Waste disposal proposals / techniques, Power Supply (KVAH) requirements etc.

The Proposal Submissions shall also accompany the following:

- Details of the Applicant
- Scope of the project
- Project deliverables and its measure
- Assumptions, constraints and dependencies
- Clearances/approvals required and responsibilities
- Base line project cost estimates capital and O&M
- Project team, safeguard business and employment interests of local populace previously involved in the meat trade.
- Any other requirements anticipated from MDCAP / GoAP

The subject land parcel(s) shall be given on long lease to the reputed Company(s) on a fixed fee towards lease amount payable to the MDCAP on Monthly / Quarterly / Annual basis. The risk of Capital investment towards establishment of these unit(s) shall be on the selected bidder pursuant to RFP process. The operational and price risk shall be absorbed by the Selected Company(s).

MDCAP or GoAP shall NOT bear any expenses or costs. These costs or expenses shall solely be borne by the MNCs / Reputed companies / Project implementation agencies/ SPVs etc., with which government shall enter an MOU / MOA for establishment, operating / running the subject unit and its day-to-day operations.

Operating expenses includes Salaries for the employees, all expenses towards logistics, supply chain network, Raw material purchases, factory/ industry running expenses / costs, all maintenance and operating expenses including but not limited to electricity bills, water usage, taxes, registration of lease and license agreements and any such other activities etc. MDCAP shall provide all necessary assistance (Single Window Policy) for the industries wrt clearances and applicable incentives from time to time.

MDCAP shall review and assess all the clearances required for the project —environment, pollution, ground water, flight path etc., and the MDCAP shall assist the selected bidder for obtaining the same and it's the sole responsibility of the selected bidder to process all the required documentation so as to obtain such clearances as one of the "Condition Precedent" to the project and the project proponent shall be responsible for completion of the same before deciding over site selected for the project.

**Key Objectives of the Project** –Regulate meat business as per, the food safety act in vogue - FSSAI in the given land parcel and make available hygienic meat to public, to reduce environmental pollution & to alleviate animal cruelty in the whole process.

### 4. CONFLICT OF INTEREST

- a. The Authority requires that the Applicant(s) provide professional, objective, and impartial services and at all times hold Authority's interest's paramount, avoid conflicts with other project(s) or its own interests, and act without any consideration for future work.
